Why write a will?

A valid will is the only guaranteed way for your wishes to be carried out and for your legacy to reach Britten Pears Arts.

Take care of your loved ones

By writing a will, you can be sure that your family, friends and loved ones are provided for in the future, as well as your preferred charities.

lt's simple

Writing a will doesn't have to be expensive or time-consuming. You can find a qualified solicitor in your local area using the Law Society website.

Reduce your inheritance tax

As gifts to charities are exempt from inheritence tax (\$23(1) Inheritance Act 1984), leaving a gift to Britten Pears Arts may help reduce your tax liability. Any potential tax to be paid out of your estate could be reduced or even elimated entirely.

If you leave 10% or more of the net value of your estate to charity in your will, your estate will qualify for inheritance tax at the reduced rate of 36% rather than 40%.

Everyone's tax situation is different. Your solicitor will be able to tell you more about the ways charitable giving may reduce inheritance tax on your estate.



Different types of gifts

A residuary legacy

One of the easiest ways to leave money to a charity. This is the balance of your estate after all taxes, expenses and other gifts have been paid. You may leave the residue to one person or organisation, or you can divide it among any number of beneficiaries. The value of this type of gift will increase as the value of your estate increases.

A pecuniary legacy

A fixed amount of money. Over the course of time, this type of gift will lose value because of inflation and you may, therefore, wish to index-link your cash gift.

A specific legacy

A gift of specific property such as antiques, shares or paintings. The Item(s) must be clearly described in your will to avoid any possible confusion. If the will does not identify the property clearly, the gift may fail. Remember, also, that if you dispose of the property in your lifetime, it will affect the gift in your will.

A reversionary legacy

This is the means of leaving a gift to a chosen beneficiary such as Britten Pears Arts, while meanwhile allowing another person to have the use of it during their lifetime. For example, you may want someone to have the use of your home for the remainder of his or her life, or of the income from a fund. When they dies, the item will then pass to Britten Pears Arts.

Unrestricted gifts are particularly valuable as they enable Britten Pears Arts to use your donation where the need is greatest. If you would like to support a particular area of work that is important to you, we would be happy to discuss this further.



How to leave a donation in your will


Wording for your will

We strongly recommend that you speak to a solicitor about writing or amending your will to include a legacy to Britten Pears Arts. The name of the charity to include in your will is Britten Pears Arts (registered charity number: 261383).

If you wish to make an addition to an existing will, you can write a codicil to be kept alongside your will. You can find a downloadable codicil form on the Britten Pears Arts website:

It's vital to review your will at intervals to ensure it still reflects your wishes and circumstances. For instance, if you move to a new house or get married, or someone mentioned in your will predeceases you, you may need to change it. Speak to your solicitor or bank about the simplest way to revise your will quickly and cost-effectively.
